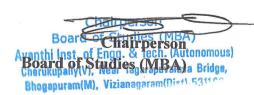

Item 1:

Welcome Address by the BOS Chairperson.

Resolutions:

- Dr. U. Ramu, Associate Professor & Head, Department of Management Studies, and Chairperson Board of Studies, extended a warm welcome to all the esteemed BOS members. He conveyed heartfelt gratitude for their presence and the valuable time they dedicated to the academic deliberations.
- Chairperson presented a summary of the Minutes of the 2nd BoS Meeting and confirmed that the Regulations (R24), along with the I MBA Course Structure and Semester- I & II Syllabus, were approved by the 1st Academic Council without any modifications.
- Chairperson highlighted that the syllabus must align with Outcome Based Education (OBE), which is a mandatory requirement in view of the revised NAAC accreditation framework and the National Education Policy (NEP)-2020.
- With the consent of the BOS members, the Chairperson informed that the implementation of the R24 Curriculum and Syllabus for the Academic Year: 2024–2025 admitted batch (I Year, I and II Semesters) was successfully carried out.
- The Chairperson presented the Proposed Course Structure and Syllabus for II MBA II Year Semesters I & II. He emphasized the need to strengthen industry-academia collaboration in designing a curriculum that is contemporary, holistic, and career-oriented, ensuring that it addresses current trends and employer expectations.

Item 2:

To discuss, review, and approve the proposed curriculum for the MBA Program for II MBA –I & II Semesters, effective from the Academic Year 2025–2026:

Members Suggestions:

- The members of the Board of Studies thoroughly reviewed the proposed curriculum for both semesters.
- A suggestion was made to adopt a **single specialization model**, as followed by several universities, to promote deeper subject expertise.
- However, the BOS Chairperson emphasized that in alignment with the National Education
 Policy (NEP) 2020, students should be offered greater flexibility and a broader learning scope.

Therefore, the Chairperson proposed the inclusion of dual specializations.

• The **Dean of Academics** supported this proposal, stating that although JNTU-GV currently follows the **R19 syllabus**, it is essential to revise the curriculum in accordance with **NEP 2020 guidelines**. He further noted that several autonomous colleges under JNTU-GV have already implemented **dual specializations** with university approval.

Resolutions:

- After detailed discussions and careful consideration of members' opinions and student employability, the Board unanimously resolved to implement Dual Specializations.
- Students will be allowed to **choose any two specializations** from the following:
 - Finance
 - Human Resource Management
 - Marketing
 - Business Analytics
- The Board of Studies approved the proposed course structures for II MBA I and II Semesters with the inclusion of Dual Specializations, effective from the Academic Year 2025–2026.
- After detail Brainstorming on Specializations and Majority members opinion and students employability finally are agreed to implement Dual Specializations (out of Finance, HR, Marketing and Business Analytics Choose any Two)
- The members of the Board approved II MBA I and II Semesters curriculum with Dual Specializations.
